OUR SHARING OF INFORMATION ABOUT YOU WITH OTHERS

As permitted by law, we may disclose some or all of the information we collect to third parties. Information is shared for the following purposes:

- Running credit checks;
- Obtaining payment for back rent and damages to the leased premises.

YOUR AUTHORIZATION
